PUBLIC NOTICE
Fraudulent Activities Impersonating RK Global Shares & Securities Ltd.

It has come to our attention that an unidentified group of individuals has been fraudulently impersonating RK Global Shares & Securities Ltd., engaging in unauthorized activities under the claim of being authorized representatives of our company. These malicious activities have resulted in financial harm to unsuspecting depositors, causing significant damage.

Details of the Fraudulent Scheme:

Fraudsters are posing as RK Global Shares & Securities Ltd. through a fake mobile application named "RKGBLSES," which is distributed via APK files (not available on Google Play Store). This app mimics our company's branding and services, with over 60,000 downloads.

These individuals have created multiple WhatsApp groups (e.g., "Q2-Market Analyst," "Q2-RX Global," "VIP Service Group") to lure victims by offering false investment opportunities and "guaranteed" profits.

They employ a two-phase strategy:

- **Small-Scale WhatsApp Groups:** Victims receive personalized investment tips, guided by an alleged "teacher."
- **Large-Scale WhatsApp Groups:** Fabricated success stories are shared to build trust and convince new victims to participate in fraudulent schemes.

Victims are manipulated into participating in a so-called "Block Trade Model," where they are required to submit sensitive personal information (such as bank details) through a fraudulent Google document.

Fraudsters are falsely linking RK Global with SIG International Group LLP through morphed images and fake news articles, falsely portraying an alliance to gain the trust of victims.

Fake pamphlets have also been circulated, misusing our logo and branding, purporting collaboration between RK Global and SIG International Group LLP.

Additionally, it has come to our notice that a mobile application titled "**TriGena**," available on the Google Play Store, and a WhatsApp group named "**TriGen PS Bombay Bullshots**" have been fraudulently misusing our SEBI registration number **INZ000187132**. These platforms are promoting trading services such as IPO participation, QIB trading, and block trading, purportedly under the name 'Trigen Securities'. These services are allegedly being managed by individuals named **Mr. Rachit Goel** and **Ms. Divya Suchak**. We categorically state that these individuals are **not associated with or authorized by RK Global Shares & Securities Ltd.**, nor do we operate or endorse any such platforms or groups. The misuse of our SEBI registration number and brand identity by these entities is a serious violation, and appropriate complaints have been initiated with the concerned authorities.

Protect Yourself:

- RK Global Shares & Securities Ltd. **does not provide** investment tips, trading advice, or any such services through WhatsApp groups, mobile apps, or third-party platforms.
- Our legitimate mobile applications and services are **only available** through official channels like **Google Play Store** and **Apple App Store**.
- Be cautious if you are asked to join WhatsApp groups, download APK files, or submit sensitive personal or financial information through unofficial documents or websites.
- Any communication claiming to be from RK Global but originating from unauthorized sources such as **Melanie SIG, Eric Robertson**, or any of the phone numbers listed below is fraudulent:

Action Taken:

We are actively investigating this issue and have notified relevant authorities to take swift legal action against the perpetrators. We strongly advise all our clients and the public to remain vigilant and report any suspicious activity or unauthorized use of our name and logo immediately.
